THIS AGREEMENT, (hereinafter "Agreement") made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 200\_\_ by and between \_\_\_\_\_ (hereinafter "Referrer") and VALLEY BLINDS INC. shall be bound by the laws of British Columbia, and is applicable for Canadian residents only. WHEREAS, the Referrer and Valley Blinds Inc. wish to enter into this Agreement in order to define their respective rights, duties, and obligations. THEREFORE, in consideration to these terms, covenants, conditions and mutual promises contained herein, it is hereby stipulated and agreed as follows:

1. The Referrer is engaged as an independent contractor with no affiliation to Valley Blinds Inc. and shall be treated as such for all purposes, including but not limited to Federal and Provincial taxation, withholding, unemployment insurance and workers' compensation insurance.
2. This Agreement does not establish an agent/principal/employee relationship between Valley Blinds Inc. and the Referrer. The Referrer shall not have the power or authority to execute any legal documents for or on behalf of Valley Blinds Inc. nor do anything to legally obligate Valley Blinds Inc. in any manner.
3. The services provided by the Referrer shall include but are not limited to the following: providing the name, and phone number of the prospective customer interested in obtaining a mortgage with Valley Blinds Inc..
4. The Referrer will be eligible to receive up to one ounce of Canadian Maple Leaf gold coin payment based on the total sale amount excluding installation and taxes of the approved order placed within 180 days of completion of this Agreement. This Agreement is void after 180 days and should be resubmitted. Payment will be made to the Referrer within 5 business days of the final installation and will be delivered to the address listed on this Agreement. (See attached Schedule A for terms of rebate payment)
5. The Referrer fee will be paid to the Referrer one time, per client, per paid transaction.
6. This Agreement and the relationship created hereby may be terminated by either party hereto at any time upon notice given to the other.
7. By signing below the undersigned stipulate and agree that they have completely read this Agreement, that the terms hereof are fully understood and voluntarily accepted by them.
